## Promote Polk County as Florida's Best Place for Business

Project activity remained strong during the first quarter of the fiscal year. The pipeline included eleven new projects of which seven were manufacturing, two agritechnology, one aviation and aerospace and one life sciences and medical services. Four announcements were made and represent activity throughout Polk County.

**Dispenser Packaging Inc.**, a manufacturer of dispenser bottles and fitments for beverage machines, has leased space in Frostproof. The new manufacturer will welcome 90 news jobs with a capital investment of \$12.4 million. Amazon has announced the building of a new distribution facility located in Auburndale to employ 500 new jobs and be a \$70 million capital investment for the company. A manufacturer of air filters, Pamlico Air, announced they have purchased a facility in Lake Wales. The new company will open 200 new jobs and capital investment for the project is \$10 million. Summit Consulting has made the decision to expand its Lakeland location into a new facility in downtown Lakeland. Summit provides workers compensation insurance products and services. Capital investment for the project is estimated to be \$50 million and 500 have been retained through this expansion.





CFDC's Vice President of Business Development Jennifer Taylor and Haines City EDC President Cyndi Jantomaso joined other economic development professionals at Area Development's 10th Annual Women in Economic Development Forum in Chicago. Attendees heard from leading women site consultants, industry and economic development experts and participated in roundtable discussions that focused on the trends influencing corporate location strategy.

In November, the Lakeland Chamber of Commerce and the CFDC hosted the 5th annual international trade symposium **Polk Goes** Global. CFDC's Director of Business Development and Global Trade Javier Marin moderated discussions on tariffs and their impact on global trade and local businesses.

In early December, members of the CFDC Business Development team attended the Area Development Consultant Forum in Houston, Texas. Attendees heard from and networked with leading site consultants and industry experts about corporate site selection and economic development trends.

### Advocate for key Business Issues

In November, CFDC staff visited the South Florida operations of Brightline, soon to be Virgin Trains, to learn about Transit Oriented Development. As Brightline continues to build its presence within South Florida and with the highly anticipated 2022 opening of their Orlando Station, Central and South Florida will become more connected than ever.

Adding high-speed rail as a transportation option with a stop in Polk County is a conversation we must continue. In addition, exploring the opportunities available through transit-oriented development that connects walkable mixed-use residential and commercial spaces to public transit.

## Facilitate Collaborative Partnerships

December started with CFDC's **Annual Investor Holiday Reception**, held at Grove Roots Brewing Company in Winter Haven. Thank you to our investors for joining us and for your continued support in building Polk County's economic prosperity.







### **Advance Strategic Initiatives**




### **POLK COUNTY ECONOMIC UPDATE** *Prepared by Jim Farrell, Ph.D., CFA, Florida Southern College*

The unemployment rate has improved from August, with the county and state rates at 2.7% and 3.2%, respectively for November. These historically low rates should continue to drive Labor Force and Employment Growth. Polk County labor force (1.05% growth to 305,445 people) and employment levels (1.58% growth to 295,783 people) grew more slowly than the state for the prior 12 months. Most of the recession talk has subsided and the economy continues to steadily improve.




### LABOR MARKET STATISTICS (NOVEMBER 2019)

From September 2019 through November 2019, according to My Florida Regional MLS, home sales were up 12.1%, while the median sales price was up 8.9%, year-over-year. According to the Census, new single-family permit requests increased 49.5% and the average value of each permit increased by 10.0% for the period. In addition to the single-family home permits, the Census reported 786 multi-family permits between September and November. The increases in multi-family permits is meaningful for continuing to provide affordable housing options in a period of increasing building cost. Polk County continues to show solid gains in key areas of the economy with housing and employment keeping pace with each other.
