


PROMOTE POLK COUNTY AS FLORIDA'S BEST PLACE FOR BUSINESS

Polk County eagerly awaits the announcement of **six new projects** totaling over **500+ new jobs** and **capital investment of \$576,946,491**. The projects represent a variety of sectors including manufacturing and research & development throughout a number of Polk County communities.

This quarter the CFDC launched a new research tool to help site selectors and business seeking locations for commercial facilities, manufacturing plants and more. The **Real Estate & Site Search website tool**, available on the CFDC website, is accessible through several places on the organization's site, including under the Do Business Here heading and Resources. The search tool further helps showcase Polk County as Florida's Best Place for Business.

The new feature allows users to search for properties by everything from type, square footage and location to demographics and workforce, targeting particular categories that a business might need. It focuses on businessuse property, including commercial, industrial, warehouse, office space, land, retail and multifamily dwellings. There are many layers and maps available to provide detailed analysis.



This quarter business development team members attended the Florida Economic Development Council Annual Conference, explored opportunities in the autonomous technology sector at AUVIS – Xpotential, learned more about the Robotics Industry at the Robotics Summit and Expo and networked with companies looking for new opportunities at SelectUSA.

Multimodal transportation continues to be an exciting infrastructure opportunity that we remain interested in learning more about and how it may fit into Polk's future.




POLK COUNTY ECONOMIC UPDATE


At the county and state levels, the labor market remains nearly unchanged, year-over-year. Unemployment fell slightly and remains below the full employment level of 4 - 5%. Total employment sits at just under 332,000. While unemployment remains low, the number of people in the labor force and employed have fallen off their highs, and this may be an early sign of an economic pullback.

At the national level, most data points to an economy that has worked through the COVID-era issues, with inflation returning to normal, albeit at higher prices. We continue to have housing shortage issues, compounded by higher-thanaverage interest rates. The Federal Reserve continues to signal that at least one rate cut is coming this year.




Labor Market Statistics (May 2024)

From March through May 2024, according to My Florida Regional MLS, home sales were down 3.5% while median prices were down 1.1%, year-over-year. According to the Census, new single-family permit requests increased 2.7% while the average value of each permit was up 19.0%, year-over-year. Multi-family construction picked up with 468 new permits. Except for new permit values, the pricing and sales data suggests that the housing market continues to be heavily impacted by the high interest rates, which are limiting transactions and prices. It will likely take several interest rate reductions to entice existing homeowners out of their current mortgages and back into the market.
