### **HIGHLIGHTED PROJECTS**



Advanced Drainage Systems (ADS), is a manufacturer of high-performing, durable pipe and innovative stormwater management solutions. The company has announced the construction of a new, \$250M flagship plant in Lake Wales that will add 200 new jobs with an average annual wage of \$55,500+.



D.R. Horton announced the construction of their new 40,000 sq ft regional headquarters in Davenport. Polk is an important market for the firm and the new \$15.9M regional operations hub will add 117 new jobs with an average annual wage of \$138,000.



Equipment Share is a construction and heavy equipment rental company bringing 40 new jobs with an average annual wage of \$50,000 to Mulberry. The \$40M capital investment in their new facility is a key linkage within their operations throughout Central Florida.



Niagara, a beverage manufacturer, is investing \$421M in a new facility to be located at the Integrated Logistics Park in Winter Haven. This new 1M sq ft building will add 22 new jobs with an average annual wage of \$56,000+.



Novaphos, announced a local expansion to construct a 40,000 sq ft manufacturing and processing facility in Fort Meade. The company will add 28 new jobs with an average annual wage of \$56,000 as part of the \$34M expansion.





RealCold, a national cold storage provider, has broken ground on a \$66M cold storage facility in Auburndale. This marks a significant milestone in the company's expansion and commitment to providing industryleading storage solutions, bringing 94 new jobs at an average annual wage of \$57,000+.

Sika, a local chemical manufacturer, announced an expansion to construct a 20,000 sq ft manufacturing facility, investing \$10M in construction and equipment. The project will create at least 10 new full-time jobs with an average annual wage of \$95,000+.



WellDyne is expanding their local employment in the Health Sciences industry in Lakeland by adding 250 new jobs at an average wage of \$64,485.

Hosted in the Skylight Hangar on the SUN 'n FUN Expo Campus, the CFDC was pleased to gather leaders from across Polk County for the 2024 Annual Meeting. During the event, **Camp Margaritaville** was honored with the George W. Harris Jr. Economic Development Award for Success in Large Business, and **Straughn Trout Architects** received the Jim Brantley Economic Development Award for Success in Small Business.

"These companies, along with all the finalists, represent the very best of Polk County," said Sean Malott, President & CEO of the CFDC. "They are passionate about their companies and the people who work there, committed to giving back to the community in many ways and enthusiastic in helping make the county the best it can be. Their leaders are the cream of the crop."

Also at the meeting, **Commissioner George Lindsey** was presented the Chair's Award from outgoing Chair Gene Conrad, President & CEO of the Aerospace Center for Excellence.

"This evening, we celebrate a remarkable leader, a dedicated public servant and a champion for economic development in our county," Conrad said. "For several years, this individual has served as the liaison between our organization and the County Commission. And in that time, we have seen firsthand the impact of their commitment and vision.

As a strong businessman, he understands the challenges we face and the opportunities we can seize. His insights have not only guided our initiatives but have also inspired us to think bigger and bolder."

Gene Conrad welcomed the Deputy Under Secretary for Operations for the National Oceanic and Atmospheric Administration, **Vice Admiral Nancy Hann**, as the keynote speaker for the evening. She is responsible for the day-to-day management of the agency's operations and is a key advisor to the Under Secretary of Commerce for Oceans and Atmosphere on NOAA program and policy issues.

As Hann explained what NOAA does, she talked about how it tracks weather, including Hurricane Milton. The agency worked alongside the Federal Emergency Management Agency (FEMA). They assisted in recovery post-storm, making sure the Port of Tampa opened as soon as possible.

Admiral Hann repeatedly praised Polk County and its residents. It is "absolutely an opportunity and privilege to serve Central Florida," she said. "We are all over this community, and I could not imagine a better place to do that work." As the last order of business, Conrad handed the Chair's position to **Dave Shepp**, a Partner with The Southern Group.

Shepp thanked Conrad for being a oneof-a-kind leader. "Your energy, wit, drive for success and pursuit of excellence has excelled CFDC. We have been fortunate to have your leadership."

## POLK COUNTY **AT A GLANCE**

The unemployment rate in Polk County is in the normal range at 4.6%, slightly above the rate of 4% from August 2023. The labor market has settled a bit with employment levels dropping through the first part of the year and unemployment rising slightly as the Federal Reserve began to loosen monetary policy in the 3rd quarter.

Since 2019 (pre-pandemic), our Labor Force grew by 14.8%, Employment grew by 14.1% while Unemployment is up by 28.8%. Over the past 12 months, we saw job expansion in most industries, with the largest growth coming from Education and Health Services (+5.4%). We did see contraction in Information (-4.2%), however Mining, Logging and Construction (+4.3%) and Manufacturing (+2.1%) returned to job growth.

### POPULATION

Polk County outpaced the state and nation in population growth between the July 2023 and April 2020 estimates, growing 12.9% as compared to 5% and 1% for the state and nation, respectively. Within the larger cities (populations greater than 5,000), growth is being led by Davenport, Haines City, and Auburndale, with all more than 25% estimated growth over the period.

### AGE

The county's age distribution reflects a larger portion of younger people (22%, under 18) than the state (19.4%) and a larger population of older people (19.4%, 65 and over) than the nation (17.7%). Both Florida (21.7%) and Polk County have older populations than the national average, however, the county's proportion of older people fell while the state's rose over the past year. The larger portions of younger and older people negatively impact our economy as it results in a smaller population of working age people, as reflected in the smaller labor force population (56.5%, 59% and 63% for the county, state and nation based on 2018 – 2022 data, respectively).

### HOUSEHOLD

Polk County continues to have higher than average homeowner occupancy (69.8%, 66.9% and 64.8% for the county, state, and nation, respectively) and lower than average costs for both homeowners and renters.

Polk County has also seen meaningful growth in taxable property values, with total taxable value increasing from \$59.5B in 2023 to \$66.3B in 2024 (+11.4%), with over \$2.7B of that attributable to new construction. Taxable new construction continues to be concentrated in Haines City (\$353M), Winter Haven (\$245M), and Auburndale (\$191M). The substantial increase in taxable value should provide a meaningful revenue increase for the county to alleviate the growing costs that come with the population growth the county has experienced.
